What is known about COVID-19?

- Infection with SARS-CoV-2, the virus that causes COVID-19, can result in a range of illness, from mild symptoms to severe illness and death.
- We don't know how SARS-CoV-2 will affect each person.
- Some people, such as adults 65 and older or people with certain medical conditions, are more likely than others to become severely ill.



How to prevent COVID-19

- Wear a mask that covers your mouth and nose.
- Avoid close contact with others. Stay at least 6 feet (about 2 arm lengths) from other people.
- Avoid crowds and poorly ventilated spaces.
- Wash hands often with soap and water.
- Use an alcohol-based hand sanitizer with at least 60% alcohol if soap and water are not available.
- Avoid touching your eyes, nose, and mouth with unwashed hands.
- Clean and disinfect frequently touched surfaces daily.
- Get a COVID-19 vaccine.



COVID-19 vaccination is a safer way to build protection

- Getting the virus that causes COVID-19 may offer some natural protection, known as an antibody or immune. But experts don't know how long this protection lasts.
- The risk of severe illness and death from COVID-19 far outweighs any benefits of natural immunity.
- COVID-19 vaccination will help protect you by building immunity without the risk of severe illness.

Medicare & COVID-19 Vaccines

- Added as Part B preventive service with no copay or deductible
 - Covers [FDA-approved COVID-19 vaccines](#).
 - Medicare also covers [COVID-19 tests](#), [COVID-19 antibody tests](#), and [COVID-19 monoclonal antibody treatments](#).
- Medicare Advantage (MA)
 - MA plan members pay nothing for vaccine, no copay or deductible
 - Providers bill Original Medicare for vaccine administration in calendar years (CY) 2020 and 2021
 - Through 2021, no plan network restrictions for MA plan members to get their vaccine

Other Coverage for COVID-19 Vaccine Administration

Medicaid

- Must provide vaccine administration at no cost to beneficiaries during the PHE
- Post-PHE states can reevaluate policies based on populations and amend State Plans as needed

Private Insurers

- Most private insurers cover vaccine in and out of network at no cost

Uninsured

- Health Resources and Services Administration (HRSA) program to reimburse vaccine administration for uninsured and underinsured individuals

Overview & Background

- An Executive Order issued January 28, 2021 created an emergency Special Enrollment Period (SEP) due to the COVID-19 Public Health Emergency (PHE), to allow individuals and families to apply and enroll in the coverage they need
- Available February 15 – Aug 15, 2021
- Available to consumers in the 36 states using the HealthCare.gov platform
- At least 13 of the remaining states and the District of Columbia are offering a similar opportunity through their own Marketplace platforms

Special Enrollment Period: Feb. 15 – Aug. 15

- People seeking health insurance can go to HealthCare.gov right now, until Aug. 15th because of a Special Enrollment Period.
- 9 out of 10 people who enrolled got financial assistance.
- 3 out of 4 currently enrolled can find plans for \$50 or less.
